Heat Pump Incentive Program Guidelines

Alaska Power & Telephone Company is expanding its commitment to clean energy and economic development in rural Alaska by providing an incentive program for electric air and ground source heat pumps. (ASHPs and GSHPs). The program will be offered on a first-come, first-served basis, with a total of 10x \$500 incentives available. After this initial round of incentives, AP&T will evaluate use of the program for potential continuation as part of its beneficial electrification strategy.

Eligibility

1. Applies to systems installed after March 1st, 2021. AP&T may request documentation verifying the date of installation.
2. Only applies to communities where AP&T's regulated power subsidiary, Alaska Power Company (APC), provides service.
3. AP&T will limit incentives to one per customer, and to one per legal address.
4. The incentive is available equally to all customer types (residential, consumer, etc.) and entity types (individual, family, non-profit, business, tribe, local government, etc.)
5. AP&T will accept an application only after the heat pump has been successfully installed. AP&T will not set-aside incentives for units to be installed in the future.

Technical Requirements

1. Must be an air-source or a ground-source heat pump.
2. Must be a new system (not used or salvaged).

Payment Details

1. AP&T will provide a payment equal to the lesser of \$500 or the cost of the heat pump (including installation) to the customer after AP&T personnel have verified via inspection that the system is present and operational.
2. Funds will be made available on a first-come, first-served basis based on the order in which applications are received by AP&T. The time at which applications are received at the email address Jason.c@aptalaska.com is considered controlling.
3. Does not apply retroactively to heat pumps installed, purchased, or under contract prior to March 1st, 2021.
4. Program will remain active through 2021.
5. AP&T reserves the right to cancel or modify this program at any time.
