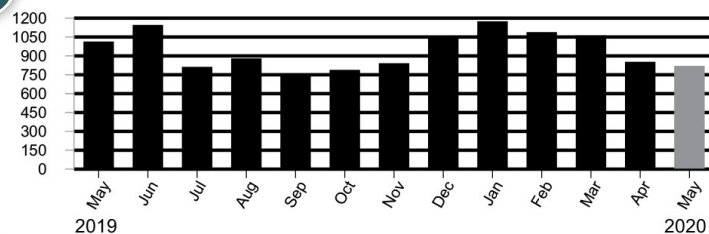

The Total Due box shows the balance on your account at the time of this billing, this includes Past Due & Current Charges Current Charges box are due by this date.

If the past due amount is not paid prior to this current billing you will receive a past due notice and your service is subject to disconnection and a Premise Visit Field Charge.
